

Our Origin

Bite Investments is a global financial technology company focused on modernizing access to alternative investments. Founded in 2018 as a spin-out from VCP Advisors (established in 2009), Bite Investments brings together deep experience in alternative asset management with technology solutions for fund managers, wealth managers, fund administrators, and investors worldwide.

The business was conceived in 2009, when William Rudebeck and Henry Talbot-Ponsonby co-founded Venture Capital Partners, later VCP Advisors and now VCP Apex. In advising managers and investors, they recognized the lack of digitalization and innovation across the alternative asset management industry. Bite Investments was seeded and incubated within VCP Apex to address this gap by creating solutions for all types of alternative asset managers, regardless of geography or investor base.

Bite Investments' first product was a digital platform that enabled high-net-worth individuals and their advisors to access leading alternative investment opportunities in a seamless and efficient way, now known as Bite Asset Management. This experience laid the foundation for Bite Stream, now its flagship technology platform. Bite Stream is an award-winning fundraising and investor management solution that provides managers with a configurable end-to-end platform for their investor base, from onboarding to reporting.

Today, Bite Investments still offer tailored investment solutions, as well as fund structuring, and wealth services. Together, these form an integrated ecosystem designed to bring efficiency, transparency, and greater access to private markets globally.

William co-founded VCP Advisors in 2009, building it into a leading corporate finance and alternative asset management advisory firm that advised on over \$20 billion of transactions. In working with managers and investors, he and his cofounder identified a lack of innovation and digitalization in the industry, which led to the creation of Bite Investments. Initially seeded and incubated by VCP Apex, Bite Investments was founded to give alternative asset managers access to modern, scalable technology, regardless of geography or investor base.

Since launching Bite Investments in 2018, William has led the company's strategy and expansion. Today, the firm has more than 80 employees across six offices in Europe, Asia, and the US, serving clients on six continents. He continues to drive growth through his expertise in business development, sales, and corporate finance, supported by a global team with deep experience in financial services and technology.

Henry co-founded VCP Advisors (now VCP Apex) in 2009, following an early career as a barrister and later at investment bank Grisons Peak. 


